### 2. Matters Arising and Outstanding Actions from previous meetings not covered elsewhere

**RT** to ensure that the MVCF website indicates that the Forum endorses 20mph limits in towns and villages. **Completed.** The website now indicates that we support 20mph speed limits and reasons to do so.

JA to write to the Surrey Police Commissioner (Lisa Townsend) about our concerns that the recent changes to the Highway Code have not been widely publicised. JA has done this, and invited Lisa Townsend to attend the Forum, but has received no response. Meanwhile RT point out that on July 12<sup>th</sup> the Government THINK! campaign was launched to improve road safety for those most at risk. Regarding the Dorking Town Partnership "Place Making Report" (see <u>https://dorkingtownpartnership.co.uk/wp-content/uploads/2022/02/211214\_Dorking-town-centre-place-making\_final-report\_web.pdf</u>) which states that active travel, walking and cycling could benefit the town more, JA & RT have submitted a response via <u>https://futuredorking.commonplace.is/</u> RH added that the Town Partnership will be restarting after a short hiatus.

### 3. Local Cycling and Walking Infrastructure Plan (LCWIP)

After a day spent cycling around the Leatherhead/Ashtead/Bookham/Dorking area with consultants from Atkins, members of the Forum and other interested parties, a follow-up workshop was held (via Teams) on 28th July attended by JA, JD, LS and SP, after which some notes were distributed.

These proposals were discussed and commented on at length, as a result of which a response has since been prepared and returned to Atkins, and shared with those at the meeting and involved with the process. ### 6. Route & Infrastructure Updates

#### Leatherhead/Ashtead area

Kathy Pike alerted us by email to a Surrey Highways consultation on Leatherhead High St at <u>https://www.surreysays.co.uk/environment-and-infrastructure/high-street-church-street-leatherhead-pedestr/</u> (which closed on 10/08/22). JD pointed out that this is effectively the Traffic Order agreed at the Mole Valley Local Committee meeting earlier this year during/after which she had raised questions about the possibility of contra-flow cycling being permitted. Post-meeting note: RTsubmitted the following shortly before the consultation closed: "It is very welcome to see the pedestrianisation continue, however an opportunity has been missed to introduce a contraflow cycle scheme to further encourage a shift to 'active travel' modes (e.g. cycling), to improve cycling safety and support Surrey's LTP4."

### Trig Street (Newdigate)

PT-D reported that Cllr Helen Clack was now on the case and pushing for this to proceed. PT-D also suggested that with the extension of the Dorking-Holmwood shared path towards Beare Green, then Trig St could, along with other

quiet lanes and off-road routes, connect down towards Charlwood and Hookwood and the route back up to Reigate. Specific reference to this has been included in the feedback provided for the LCWIP consultation.
